West Seattle high bridge to re-open in 2022

The goal of the West Seattle High-Rise Bridge Safety Project is to restore traffic in 2022," said Chris Gregorich, a Seattle Department of Transportation strategic advisor, who spoke to members of the Metropolitan Democratic Club of Seattle at its January 13 Zoom meeting. He said Mayor Jenny Durkan announced last November that the West Seattle Bridge would be repaired, as it is the fastest way to restore mobility to West Seattle. Eventually, he added, the bridge will have to be replaced.

The high bridge was closed in March 2020 because cracks were widening at an alarming pace, requiring immediate removal of traffic. This was not a maintenance issue, Mr Gregorich said, but shutting down the bridge assured that repair was a viable option. The high bridge carries over 100,000 travelers each day and its unavailability leaves West Seattle residents and businesses few options for quick access to the rest of the city.

Phase I of the repair began with stabilization; construction will be underway during the third quarter of 2021. This involves more post-tensioning work on additional bridge spans, reviewing the seismic condition of Pier 18's foundation and completing a study that models the likelihood of other parts of the bridge needing future repairs before the bridge is replaced. The repair work is expected to be complete and the bridge open to traffic around the third quarter of 2022.

To prepare for the eventual replacement of the bridge the project will conduct a traffic and revenue study to develop a long-term funding strategy and determine the type, size and location of the replacement.

To deal with traffic issues until the repair is complete the project conducted surveys to gather information from West

Stop midnight raids on people's homes

We must not forget Breonna Taylor and the many other innocent men, women, and children who have lost their lives when police SWAT teams invaded their homes in the middle of the night. The best way to honor their memory is to outlaw and completely abolish such invasions.

It cannot be a surprise that a householder will shoot at intruders who have broken in during the night. And of course the police will shoot back. Who is to blame? The people who sent them! Or consider the following possibility. Despite experience and training any officer is going to be somewhat tense and on edge going into an unfamiliar house at night. When he sees somebody coming toward him through the semi-darkness, with a gun in his hand, he shoots in self-defense. Actually, he has shot a 64-year-old man who had fallen asleep in front of the television. The noise awakened him and he started to get up with the TV remote in his hand. Well, it looked like a gun in the dark. When he learns that this was the reality the police officer is devastated, and he considers quitting the police force. Outcomes like this have happened countless times.

It is hard to blame the police officers for the inevitable damage that ensues from these events. Blame the person who sent them, and those who allowed it - the judge, the mayor, the police chief, the city councilman, the state legislator. Because this is how it often happens. A tip comes in, anonymous or from a "reliable source." On that flimsy basis someone applies for a warrant to arrest a citizen who is now suspected of having or selling an illegal drug. Without oversight, surveillance, or other confirmation, a compliant judge signs a warrant allowing a night-time

raid on somebody's apartment or house. Hopefully the address is accurate.

Police officers risk their lives every day. Sending them at night into someone's house greatly increases their odds of being shot at or even killed. Just as important, these raids jeopardize the well-being and life of everyone inside. Almost always there are men, women, or children present. Many people have been killed in the process of arresting a person who has not yet even been convicted of any crime. The disproportionality is appalling. All too often the resulting "collateral damage" really constitutes a death sentence for one or more of the innocent bystanders. Yet the warrant itself was only about a minor crime, certainly not punishable by death. And the experience of having your door broken in, your house torn up, weapons displayed and pointed at your head, while being loudly cursed - all that is incredibly traumatic. The children will have nightmares about that invasion for the rest of their lives. So will most of the adults.

Some proposals have recommended ending "no knock" warrants. That would not help very much. If someone pounds on your door at one AM, yelling "open up," and claims to be the police, it is not much safer and no less traumatic than a no knock entry with a battering ram.

In 2014, Rise of the Warrior Cop was published. Written by Radley Balko, it sets forth decade by decade how ever since Reagan was president these raids have grown in number until they have become common. The notes at the back of the book provide ample source material.

SWAT teams may be needed for hostage situations, or to stop a threatened terror attack, but those situations are extremely rare. The vast majority of SWAT raids are to serve warrants, mostly for drug suspects.

Ending these raids will require one

Seattle residents about how to achieve levels of travel similar to pre-closure. It also sent ballots to West Seattle neighborhoods to prioritize projects that can reduce impacts on detour routes. Mr Gregorich noted that there had been 190 traffic improvements and 22 neighborhood ballot projects built since the bridge closure. Thirty-three traffic mitigation projects are planned for 2021,

The bridge closure necessitated a number of transit service changes, he told the group. SDOT is working with Metro on a variety of options including allowing vanpools to use the low bridge. Priority access is for emergency vehicles, heavy freight, transit (vanpools, shuttles and school buses. There is now in place an automated

photo enforcement system; unauthorized users get a \$75 ticket.

In addition to the repair of the high bridge, work has begun on strengthening the low bridge, Mr Gregorich explained. A consultant is under contract to begin designing post-tensioning and carbon fiber wrap and to investigate a center-lock system and pier conditions. Construction is expected to begin mid-July and end May 2022.

The project expects to have a more refined cost estimate early this year. The capital cost of repair is currently estimated at \$47 million; other costs include \$50 million for traffic mitigation and \$10 million for repair of the low bridge.

Community engagement includes virtual community meetings, ongoing community briefings, work with South Park, Highland Park, and Georgetown to finalize Home Zone projects, outreach on proposed W Marginal Way SW improvements, and continued coordination with neighborhoods, maritime groups and a variety of agencies.
