opinion Looking down the road: Ukraine

As the Russian-Ukraine war settles down to a pattern of artillery exchanges and limited sieges of eastern Ukrainian cities, it becomes important to visualize the probable outcome.

Given that Russia is a nuclear power with ample delivery capability, we are not going to "win" this war in the traditional sense. The best we can expect is to stop Russia by making the conquest of territory too costly to undertake. At the same time we are degrading Russia military capacity to at least some degree. It is my understanding we are doing that now with our current arms aid. But we cannot defeat a Russian army that can retreat past the Ukraine/Russia border, re-group, and attack again. We must keep these background facts in mind, as we look for a negotiated settlement. The prospects for such a settlement are not good.

temporary, but going on indefinitely will be hard to sell to the American people. It will be harder to keep the support of the NATO allies. But it is better than the alternative of a continuing low-grade war characterized by long-distance artillery shelling, sieges of civilians in metropolitan areas, and localized handto-hand combat. Such a situation, while attractive because it would be relatively low-cost to us, while Russia continues to bleed, means all of Ukraine remains a combat zone. This is a horrifying prospect for the Ukrainian people.

So let's get on with an intelligent policy of

•Initiating negotiations beginning with cease fire

•All forces to remain in place

•Early resumption of Ukraine economic activity

•Mutual commitments to observe the cease fire while negotiations continue.

WARNING TO DEMOCRATS: This will not be an easy sell in 2024.

MDC meeting notes

A summary of programs and business conducted at Metropolitan Democratic Club of Seattle meetings for April, May and June.

April 13

Program: Representative Sharon Tomiko Santos spoke on education legislation in the 2022 legislative session.

Business: MDC members voted early endorsements for the reelection of representative Roger Goodman and Senator Bob Hasegawa, both MDC members. They also voted to sponsor the Spring Gala of the Northwest Progressive Institute in the amount of \$250. Following a discussion of how to conduct A Chautauqua Afternoon this year, it was decided to vote at the April 27 meeting whether to hold a Zoom event or conduct the event by paper as we have the last two years, or both. [Followup: Representative Hasegawa is not up for reelection this year.]

April 27

Program: Gael Tarleton, director of Seattle's Office of Intergovernmental Relations explained the duties of her new job and the various roles of the department.

Business: MDC members voted to hold a fundraiser for Dr Kim Schrier for reelection to Congress, 8th CD. They also voted to conduct the Chautauqua Afternoon on paper as we have in the past two years and to hold a special Zoom meeting to which we will invite candidates to say a few words. [Followup: A Chautauqua Afternoon was cancelled due to lack of response from candidates. Those candidates who did respond were invited to attend MDC's June 22 endorsement meeting.]

May 11

Program: Dr Sarah Binder spoke on the history and future of the filibuster. Dr Binder is a senior fellow in governance studies at the Brookings Institution and professor of political science at George Washington University, specializing in Congress and legislative politics. She has published widely on legislative issues, including the filibuster.

May 25

Program: Troy Davis, Logan Bowers and Zachary Collins of the Seattle Approves campaign spoke about Initiative 34 which, if passed, would change the way Seattle votes for mayor, city attorney and city council members. Voters would be able to choose multiple candidates in the primary. The two candidates with the most votes would advance to the general. [Followup: the campaign has secured enough qualifying signatures so the initiative will appear on the November ballot.]

June 8

Program: Andrew Lewis, Seattle City Councilmember for District 7, spoke about safety in downtown Seattle, including issues related to the hiring and retention of police officers.

June 22

Business: Primary endorsement proceedings. Please see endorsements, page 1. Directors Joanna Cullen, Judi Gibbs and Allan Munro were reelected to the Board of Directors and will serve for the 2022-2024 term.

Votes on two motions for dual endorsement of candidates will be taken at the July 13 meeting of the Metropolitan Democratic Club of Seattle. The motions are:


To endorse Emily Alvarado and Leah Griffin for Representative Position 1 in the 34th LD, YES or NO.

To endorse Nicole Gomez and Jeff Manson for Representative Position 1 in the 36th LD, YES or NO.

There was no simple majority in either race. The named candidates received the highest number of votes. According to the bylaws of the MDC,

"Section 6.4 Dual Endorsements, If no candidate in a particular race receives a simple majority, a motion may be made to endorse the two candidates who receive the most votes. No other motion concerning that race shall be considered. A dual endorsement requires that a twothirds majority of those voting approve the action."
